Purpose of Meeting

1. Activity since October 2013

TL presented an overview of housing matters:-

- publication of the Housing Needs Survey (HNS)
- progress on Neighbourhood Development Plan (NDP), incorporating

evidence from HNS.

- loss of appeal at Swallowcroft and SDC refusals in Bath Road
- fluid situation of SDCs Local Plan, currently showing 11,200 houses

and alleging the need for West of Stonehouse

2. Alternative ways of managing a CLT build project

2.1 Ian Crawley provided a diagram of the choices open to a CLT (attached).

The principal choice is between partnering with a Housing Association (HA), shown as the top row of activities, and going-it-alone, shown in the bottom row. Deliverables common to both processes are shown in the narrower central row.

90% of CLTsgo down the partnership route, motivated by less risk and quicker results (2-3 years for HA against 5-7 years for go-it-alone. For a second project, more CLTs have confidence and resources to go-it-alone.

At least 3 HAs have indicted to IC that they would be interested in partnering Eastington.

A key determinant in fixing rents is whether the Government (HCA) is used for finance. HCA *tends to prefer* 80% of market rents whilst a wider definition of "affordable" is 65%, which is the SDC average

- 2. A healthy Q&A explored both options further and a coffee break was useful for contemplation. Cllr Stephens left the meeting .
- 3. The meeting considered that we did not have the technical resources for go-it-alone at this stage. It was unanimously agreed to invite HAs to consider partnership for the first project but not to rule out go-it-alone for a second project.

IC named Two Rivers, Aster Homes and Rooftop HA as being interested but the meeting agreed to write to all HAs known to be active in the region (believed to be about 8), including the three mantioned

3. Land Negotiation

AN, Muriel Bullock and TL were unanimously appointed to discuss confidential matters with landlords offering land.

All discussions would be brought to the Steering Group for deliberation before any hard and fast agreements are made.

In the interests of openness, all known land owners and land agents with at least an acre of land would be written to explaining the aims of the CLT and be invited to offer land fulfilling our criteria.

4. Administration

The CLT remains a sub-cttee of the Parish Council until such time as a formal constitution is settled upon. Minutes of meetings will be passed through to the Parish Council.

A website will be established upon which agendas, minutes and membership can be seen. It is expected that the Parish Council website will have a link pointing to the CLT website.
