1. Attendance and Apologies for absence

- 2- Minutes from previous meeting: No comments from the group
- 3 Financial report: On time, 2 new members, (KG) to stand down as treasurer as of 20/10/16. Need to find a new treasurer.

7 - Progress on ground survey report phase 1-TL reported complete with no concerns. Need to discuss best way of sharing these (quite lengthy and detailed) documents

8 - Progress on sound survey and topographical survey - on going, (AB) requires a map of exact location for houses as site is greater than the size required for the houses. (AL) took proposed architect to the site so was able to give (AB) verbal information of where the proposed site is.

- 10 Presentation to Parish Council on 27/10/16: (TL) & (SW) to present information. Discussion took place regarding one of the Parish Councillor's objections to the ECLT and

their commenting miss-information on the Love Eastington site. The information presented on the 27/10/16 should answer the concerns.

- 11- Date to be agreed for AGM: (MB) to check availability of venue within the parish, proposed dates are 7th & 8th December.
- 12 AOB (IC) will advise if there is someone available at his end to come to the Parish Council meeting on the 27/10/16 to answer any questions put forward by the Parish Council. (IC) has offered to come to the AGM and give information to the members regarding the existing CLT in Nailsworth. It has been noted that the Parish Councillor who was appointed to sit in on the meetings to observe has not been present for any of the meetings the ECLT have had.
