2. Approval of Minutes

The minutes of the Board Meeting of 6th June 2019 were unanimously approved and signed by LF.

3. Financial and Administration Report

There were two cheques for signature, leaving clear funds of £113. It was agreed to hold back the cheque for Anthony Collins until SDC had indicated their acceptance of the seventh claim (payment was not strictly due until 11th July).

TL and LF had agreed a final claim upon SDC for £2,250 which would leave less than £200 out of the £29,000 originally on offer.

4.2 Funding from Homes England

TL conveyed from KH that Aster would sign the SDC/Aster half of the transaction w/c 24th June. The other half between SDC and Homes England was agreed subject to a technical letter defining the exemption from State Aid
