

Eastington Community Land Trust Ltd. (ECLT) 101st Meeting of Board Members Village Hall at 7.00 pm Thursday 21st October 2021

Minutes

2. Co-option of Trustees

MB welcomed KC and AM, who were co-opted as Tenant Trustees under Rule D5. Both will stand for election for the usual three-year term, at the up-coming AGM.

3. Approval of Minutes

The minutes of Board Meeting of 7th October 2021 were approved and signed by MB.

4. Financial and Administration Report

4.1 Invoices

There were no invoices, the balance after all cheques have cleared was £5,582.22.

4.2 Update on Additional CHF Grant

TL and LF reported that Locality had fully approved our application and money would be delivered electronically.

LF had created new budget heads to ring-fence these funds under Budget 1200 Locality 21.

4.3 Update on SDC funds for Project Three

TL reported that Pippa Stroud had accepted and approved our invoice, which was now in the SDC creditor system.

LF had created a new budget head to account for Project 3 Capital, Budget 1100. Thus Budget 1000 for Project 3 would only have revenue budgets and expenditure.

5. Project Two

5.1 Update on legal items

TL reported that he had had to prompt Terri Hibberd (TH) over the lack of response from 2RH solicitors. A full e-mail was subsequently received by our solicitor on 22nd October.

5.2 Update on technical items

5.2.1 Landscaping Responsibilities

TL had a quotation for provision of the footpath at £7,000. However, TH confirmed that 2RH would regard both the footpath and the wildflower meadow as "main contract" items. ECLT would not have to pay the capital costs but would have to maintain after the 12-month warranty period.

5.2.2 Highways access report

Trustees discussed the implications of the Highways Consultant's recommendations for warning signs on Snakey Lane. It was agreed that TL would write to the Parish Clerk to point out the recommendations and invite Parish Council to implement the recommendations as soon as practicable.

ACTION: TL

5.3. Planning Application

TM recommended by e-mail that Board should await more progress on legal matters before authorising the planning application.

It was agreed to reconsider the application at the next Board Meeting.

5.4 Meeting with Two Rivers' Lettings manager

MB had made contact through TH with Ian Rawlings but a date had yet to be set.

6. Fullers Close grassed areas

Samantha Hale (SH) had reported that the Aster GM manager had been off with Covid-19 but was now back. The job is being contracted out. (Secy note: as of 31st October, the Aster GM contractor had not cut any grass).

TL reported a conversation with TH, confirmed by other Building Surveyors, that Contractors frequently behaved in this negligent manner. Our learning from this will be that TH will deploy 2RH's own direct labour force GM team for the landscaping elements, including the wildflower meadow. They will take responsibility for the planting and the 12-month warranty period.

2RH GM team will then continue to maintain all common grassed areas in the western portion and ECLT will maintain the wildflower meadow in the eastern portion.
