# 2. Approval of Minutes

The draft has been resolved between 2RH and ECLT and it has been sent to SDC. Because TM has stressed the importance of ensuring the cascade is consistent between Social Rented and Shared Ownership it is hoped that SDC will not have much to query.

MB reported the the Parish Council has voted £6,650 for a planning consultancy to represent the Parish at the Examination in Public.

TL suggested that ECLT formally offer assistance to Parish Council in reviewing draft responses to the Local Plan and commenting on the Neighbourhood Plan Review. To be discussed at the next meeting.
