






## Homeground - Lease and Purchase Completed!!

- ECLT's purchase of Homeground completed on 28 October 2024
- Western Portion let on 995-year lease to Two Rivers to carry out development of 31 affordable homes
- Eastern Portion retained by ECLT for future projects

- Signage erected in December 2024
- Works commenced on 4 February 2025
- Target Practical Completion in March 2026





## Looking Forward

- ECLT lobbying government for more support for community-led affordable housing in rural areas
  - 3x parliamentary questions submitted to Matthew Pennycook via Dr Simon Opher MP and responses fed back to National CLT.
- ECLT will support Parish Council in preparation of Neighbourhood Development Plan.
  - ECLT & Parish Council met with SDC Strategic Planning team on 5 February 2025 to discuss allocation of housing under Local Plan.
  - Housing Needs Survey to be undertaken in Spring 2025.
    - Housing Needs Survey will feed into later stages of NDP Review
    - GRCC approached to facilitate survey (possible alternatives)
